How does one discern what is okay to report and what isn't? How does a printing press work? How do you write an effective speech? How can we create spaces for positive discourse online? What does a career in TV news look like? How does the Dover Air Force Base share information with the public? These are just some of the questions that were answered for the Leadership Central Delaware Class of 2023 on their Media & Communications Day, beginning at the one and only Delaware State News and Delaware Printing Company.

Media & Communications is an industry that most people can find useful and combine with any other field of work. Today's media landscape is pervasive, swift, influential and more important now than ever. Prominent staff members from the Delaware State News (DSN) were present for a panel discussion to set the tone for the day on this key economic driver of Kent County. Andy West, Executive Editor at the DSN, and Amber Startt, Senior Credit Analyst at Dover Federal Credit Union, co-chaired this successful day to share just a glimpse of what the industry looks like in Central Delaware. The class came prepared with thought-provoking questions for the panel.

After a tour of the Delaware Printing Press, the class had to put on their reporter's thinking caps and voices as they completed their mock press conference exercise, reporting on a fictional shooting incident at a local apartment complex. This exercise made the group think critically about how they would report the story to the public with such little information given at the time. The class did a stupendous job of stating the facts, initializing a call of action and challenging their linguistic skills.

Once their scripts were written for the report, it was time to drive to Polytech High School for a tour of their impressive Broadcast Media Vocational Studio. Here, the new "reporters" downloaded their scripts to the teleprompter, mic'd themselves, sat tall behind the desk and delivered the news exceptionally. The supporting crew in the sound bay was equally impressed by their broadcasts. Great job to the LCD Class of 2023 on knocking this hands-on exercise out of the park! The CDCC wishes to thank instructor, Mr. Gleockler, and his wonderful students for a guiding tour of their facility and for welcoming the class.

Next, the LCD Class made their way down the halls of Polytech to the Looking Glass auditorium for lunch and the afternoon's enlightening presentations. The Polytech Culinary Arts students provided and served a delicious fueling lunch to continue the day. The first speaker of the afternoon was Darel La Prade, Delaware State News Publisher. He shared an intimate and thought-provoking presentation on "The Civility Project." This project is a new initiative from the DSN to inspire and facilitate better spaces for civil discourse, especially in online spaces. He addressed the increasing polarization of American society and its relationship to real and fake news. He stated how the DSN will continue to hold up or stand up "solutions-based journalism," focusing on transparency, accuracy, and respect from all sides of the discussion.

His presentation transitioned into a Q&A session with Torie Seagraves, WRDE NBC Coast TV News Reporter and Polytech Broadcast Media Alumni. Seagraves delivered an eloquent play-by-play of her day as a reporter, how she tackles tough and painstaking news stories, and finding her footing in her career. Everyone in the room hung on her every word when hearing about her first-hand experiences in the profession. She provided a great insight through the lens of a local young reporter.

After a short break, Andy West returned with a few striking photos from past news stories. The class had to think about whether or not they would publish photos such as a woman in visible heartbreak after a traumatic incident, or a photo documenting a victim. It's a tough line to balance

between reporting the facts and maintaining proper ethics.

On a lighter note, Dr. Rev. John Moore, nationally-renowned public speaker, Martin Luther King Jr. impersonator, and Director of Philanthropy and Engagement at the United Way of Delaware, brought his infectious energy to the day with his step-by-step demonstration on how to deliver and write an effective speech. The class took notes diligently and gave high remarks for Dr. Moore's expertise. As present and future leaders, they will certainly apply these tips and skills to their next speech.

Last, but not in any way least on the agenda, Media & Communications Day rounded out with a presentation from Veronica Aceveda, Chief of Public Affairs of the 512th Airlift Wing from the Dover Air Force Base. From her time with the class, it was helpful to learn how the Dover Air Force Base communicates with the public, locally and nationally. The class learned special techniques in answering questions and presenting information to an audience in an efficient, factual, and cohesive way. The sharing of the "Briefing Card" technique was incredibly useful to the class, as well as ways to practice comfortability in public speaking, no matter the instance.

The first class of the New Year for the LCD Class of 2023 was full of important messages - we hope the Class grasped them all! The CDCC thanks Co-Chairs, Andy West and Amber Startt, for their extraordinary help in making this day a successful one to be remembered forever. Thank you to all of the incredible speakers who added their insight to the day. 



Kent County Levy Court working to modernize codePlanning and zoning rules to be voted on soon

A half century after adopting its first set of zoning laws, Kent County leaders are in the homestretch of a major update to its planning and building

Zoning codes are developed and regularly reviewed by local governments as a tool for future planning. They are a collection of rules that determines what can be built where and how it will look and be used once completed.

On Jan. 24, Kent County Levy Court commissioners held a rare workshop with members of the Regional Planning Commission to review changes to its code that include relaxing some rules and adding others. The Regional Planning Commission is the group responsible for reviewing a project's plans and potential impacts. It forms its opinion about a project by vote, which is then shared with Levy Court commissioners as a recommendation.

Kent County's Director of Planning Services Sarah E. Keifer said the effort was to bring the rules up to current standards.

"The primary goal of doing this rewrite of effectively the front half (of the county zoning code) is to modernize it," Ms. Keifer said during the workshop. "Procedurally, after we get through the workshops and identify any revisions ... we will produce a different document. It'll be under a different number, and the public hearing process will begin."

The rewrite didn't tackle issues of signage and parking, historic preservation and airport zones but works to make the rules that were changed more user-friendly.

"It gives us a little more flexibility as markets change as economies change to accommodate that. We also very much wanted to increase the usability of the document," Ms. Keifer said.

The first step in the rewriting process included addressing typos and updating the document's language by removing obsolete uses and adding modern ones. Next, county planners created a chart to determine a project's first step. Property and business owners can refer to the table and immedi-

ately know if their proposed project is permitted or if it needs special approval.

The proposed changes include moving all general retail uses in the county's Neighborhood Business District Zoning to a permitted use status. The change will make it easier for businesses to get set up. General retail includes banks, dry cleaners, box outlets, car washes, flea markets and pawn shops.

The proposed plans also created a new section for drive-thru businesses. The section sets guidelines for lane setbacks, widths and lengths. The new document also has a new "mixed use" section that codifies combined commercial and residential spaces.

This planned ordinance also lifts current restrictions on domestic pets and adds some guidelines for the keeping of backyard chickens. Currently, in Kent County a person is only allowed to have four pets on any lot.

"This one-size fits all approach hasn't worked," Ms. Keifer said.

If adopted, the zoning law would not put a limit on pets. It would restrict domesticated fowl to five birds per

15,000 square feet of land. It also completely bans the keeping of roosters, apart from commercial farms.

"It is a complex document. As we were working on revisions, we were looking to how would somebody who isn't a planner, be able to use it? So that led to a lot of reorganization," Ms. Keifer said.

Kent County leaders wanted to start the new year with a new planning code but just hours before it was to be heard by Kent County Levy Court commissioners, some issues were discovered.

"The problem being is we found that there were some things omitted or weren't put in and we would have passed it. We would have deleted the previous document, which would have taken out all the things that we worked hard to leave here. Having found that based on our lawyers' ability to help us on this, we decided to hold a workshop to hear the document," Third District Levy Court Commissioner Allan Angel said.

The document will now go through the new ordinance process and is expected to be voted on in the coming weeks.




