

Capital Station: From Empty Factory to Bustling Shopping Center

When Playtex mothballed their factory on the intersection of Division Street and DuPont Highway, the corner went dark for nearly two decades. An important part of Dover's history, the facility on the edge of downtown had employed hundreds. As it sat empty, weeds began pushing their way up through the asphalt and the old teal water tower browned with rust.

By the early 2010s, the facility was in a state of disrepair. A Brownfield Remedial Investigation revealed that it was partially contaminated which added to the list of obstacles to repurpose the site. Nevertheless, the idea of transforming it into a modern, high-traffic shopping center began to percolate.

After navigating a complicated maze of zoning, architectural and engineering stumbling blocks, Capital Station Dover LLC (the developer) initiated the project in 2017. Several years of careful demolition and construction later, the vision was realized and Capital Station rose from the rubble.

The 60,000 square-foot shopping center quickly caught the attention of large international brands like Starbucks and Aldi. They were joined soon after by SuperCuts, Village Optical, Massage Envy, Verizon and Orangetheory Fitness. Red Robin Gourmet Burgers and Brews climbed aboard as well and is currently putting the final touches on their new location.

Not only did the development do away with a long-shuttered factory, it breathed new life into the busy corner. From dawn till dusk, on-the-go Doverites now file into the Starbucks drive thru, pick up groceries, get a massage or drop in for a quick workout. Where there was once a perimeter of barbed wire fencing, there's now a network of brand-new sidewalks – transforming it into a walkable business district. Helping to ease added traffic, multiple entrance and egress points were added to make Capital Station accessible from Maple Parkway and Kings Highway in addition to the highway and Division Street. With approximately 400 parking spots, the center holds a lot of visitors.

"It's been a great project to be a part of," said Charles Rodriguez, owner of R&R Commercial Realty. "Revitalizing

"It's been a great project to be a part of," said Charles Rodriguez, owner of R&R Commercial Realty. "Revitalizing the area with a shopping center has helped provide more high-quality amenities for nearby residents and businesses while adding jobs to the local economy and increasing the total amount of commerce taking place on Rt. 13."

As the leasing broker for Capital Station, R&R has been responsible for showcasing it to prospective tenants. Although the biggest available spaces were snatched up, Rodriguez said there are still some great storefronts available.


"There are a few spots left starting as small at 1,490 square feet," he said. "But they can be combined into a space as big as 5,225 square feet."

For some, seeing the old factory fade into Dover's past was bittersweet. But, it's undeniable that Capital Station is a part of the city's future, and the future is bright.

It's All About Headlines and Deadlines!

In January, Leadership Central Delaware explored the industry responsible for reporting and delivering our news! Media and Communications Day was chaired by Andy West, Executive Editor. Delaware State News, LCD Class of 2009 and Amber Startt, Business Services Credit Analyst/Underwriter, Dover Federal Credit Union, LCD Class of 2017. The class enjoyed a full day of behind-the-scenes activities and gained a better understanding of all the elements that go into the process of bringing "breaking news" to the people of Central Delaware and beyond.

The first stop of the day was at the

home of the Delaware State News: The State Capital Daily. There they heard from many staff members about all the aspects of producing and delivering a quality daily newspaper. From advertising to events to editing to publishing, the class was briefed on the whole process of getting the news from where it happens to subscribers' front doors. They also had the opportunity to see the presses and learn about their operation.

To help apply their newly acquired media knowledge, the class members were divided into groups and asked to generate a brief news report based on details they were given of a fictitious news event. They worked diligently to produce the assigned news story as clearly and concisely as possible. They took special care in providing all the necessary information in such a way as not to cause undo alarm or panic on the part of the receiver. They got a real taste of the weight of responsibility that rests on those who report the

The next stop of the day was at Polytech High School where Broadcast Media is one the technical areas offered to students. During their time at Polytech, class members were cho-sen to "broadcast" the news stories written by the small groups earlier in the day. Four class members (one from each group) were taken to the news desk, given a microphone, and were asked to read the news stories from a teleprompter – while facing the appropriate cameras "on the air."

After lunch at Polytech's Looking Glass Auditorium with the Broadcast Media students, the class learned from presenter Mark Hoffman of the Dover Police Department about the importance of a strong and positive relationship between law enforcement and the media. The police department depends on the media to report their actions clearly and accurately, to portray their work in a positive light which instills trust, and sometimes, to even help solve crimes.

An overall theme of the day was about putting one's personal feelings aside and developing eyes and ears that are unbiased. A great deal of emphasis was also placed on the skill of making quick, sound decisions about items that are appropriate to publish

and items that are not. To that end, two photojournalists, Gary Emeigh and Marc Clery, led the class through a slide show of vivid photographs about which they were asked to make publishing decisions. This exercise brought to light the complex and impactful nature of those decisions.

At the end of the day, two class members, Dawne Nickerson Banez and Veronica Aceveda, representing public affairs in the 436th and 512th Airlift Wings at Dover Air Force Base, offered a presentation about the relationship between the base and the news media. They shared how the delivery of news has changed in the Air Force over its history and emphasized the need for reports to be detail oriented and accurate.

For the LCD Class of 2020, Media and Communications Day was eye-opening and informative. The class members enjoyed the hands-on experiences and gained a new appreciation for what it takes for news reports to be "fair and balanced." Their exercises in reporting and decision making helped them to understand the pressure involved in "telling it as it is." It became obvious throughout the day that the news media was not only an economic driver in Central Delaware, but also an industry that carries the responsibility of having a great deal of influence on Central Delaware's leaders, decision makers, and citizens.

The Forecast is Good, According to the Experts!

et at Maple Dale Country Club on January 16th... on the outside, that is. On the inside, it was anything but quiet where over 100 member businesses, public servants, and community leaders gathered to hear about the "state of the economy." Friendly conversation filled the room where, over a delicious breakfast, much would be learned about what to expect in the world of finance over the next calendar year at the Economic Forecast Breakfast brought to the community by signature sponsor Connell, Carey, & Associates - Merrill Lynch of Dover.

The panel of experts did their best to paint a financial picture based on the market, investments, trends, and spending patterns at the national, state, and municipal levels. Jason Castellucio, a client portfolio manager for Nuveen, reported that 2019 had been a wonderful year for the economy. He doesn't expect that 2020 will yield quite that kind of robust growth and prosperity, but he believes that it will remain strong. Based on his 10 predictions regarding unemployment, earnings, equities, and politics, he forecasted that 2020 will bring moments that are "choppy and frustrating," but not devastating. He underscored

The cold morning appeared qui- that, in reality, the economy will just go back to behaving the way that it's supposed to in a normal year. Mr. Castellucio predicted that, while it isn't likely to happen in 2020, the country will experience a recession within 10 years. He cautioned that it is imperative to remain tuned in to what is happening and be ready to make prudent investment decisions.

On the state level, Edward C. Ratledge, Director of the Center for Applied Demography & Survey Research at the University of Delaware, used a series of charts and graphs to show the correlation between the changing demography of Kent County and the economy. As the population of the state ages, there will be shifts in the economy based on the wants and needs of older residents and a higher emphasis on the industry of health care. Business leaders would do well to take this into consideration in the vears to come.

Linda Parkowski, the Executive Director of Kent Economic Partnership, wrapped up the day's presentations by shifting the audience's focus to what is happening here in Central Delaware. Linda recapped the findings of the Rockport Study, completed in 2018. The study indicated that Kent County was positioned to attract businesses related to health care and small to medium manufacturing. To that end, Linda has worked hard to make connections with businesses in these industries and invite them here to Central Delaware. The focus in 2019 was on manufacturing, her focus this year will be on health care. She is currently working on 8 active projects. One challenge that Linda reported is a lack of workforce, in particular, skilled workers in the health care sector and skilled technicians for manufacturing service industries. An education/workforce committee has been established to begin to address this hurdle in a collaborative

The experts entertained questions during their formal presentations, as well as after the event. The information they shared was well-accepted. The guests were pleased to have someone interpret for them the complexities of financial predictions in a way that could be applied to their businesses. Overall, this annual event was marked by a powerful exchange of information that will have a great impact on how business is done in this new year.



His next assignment will be at Scott Air Force Base, Illinois.

Flanked by more than 35 family members and friends, Col. Jones was eager to accept his new assignment. Serving in the military is a strong and long-held family tradition. Even though it is somewhat of an unusual move for the Air Force to select a new commander from someone in the ranks at the same base, there will be several advantages for the Jones family, as well as for the base and the community: TEAM Dover. Without the upheaval of another move – the Jones family has moved 5 times in the last 6 years – Col. Jones will be afforded the opportunity to build on many relationships that have already begun. In addition, he looks forward to continuing the fine work of Col. Safranek which he and the former colonel worked on together.

In his new role, Col. Jones will be responsible for the mission of Dover Air Force Base to safely fix and fly aircraft, prepare and deploy Airmen, move cargo, and return America's fallen heroes with dignity, honor and respect. He will be charged with ensuring the well-being of the approximately 6,100 individuals who make up the base's workforce plus 5,000 family members, and of carrying out the mission of flying cargo around the world. He is eager to collaborate with local partners and maintain the strong bond the base enjoys with the local community.



Recipients can use REAP funding to install renewable energy systems such as biomass, geothermal, hydropower and solar. The funding can also be used to increase energy savings by making improvements to heating, ventilation and cooling systems; insulation; and lighting and refrigeration.

In December, Deputy Under Secretary for Rural Development Donald "DJ" LaVoy announced that the agency had invested \$237 million nationwide to help farmers, agricultural producers and small rural businesses lower energy costs.

In 2019 Delaware Rural Development provided Haven Farms with a \$121,555 grant to assist with the purchase and installation of a 281.4 kW solar array system. USDA's investment will help this farm save \$31,751 per year in en-



ergy costs and will replace 387,208 kWh per year, which is enough electricity to power 35 homes.

In 2019 Maryland Rural Development provided Gratia Plana,

sist farmers, ranchers, and rural small businesses in developing renewable energy systems and improving their operations. The funds will allow the purchase and installation of 117.72 kW solar

electric system saving the farm \$16,730 per year in energy costs. The system will generate 169,300 kWh of electricity per year, which is enough electricity to power 15 homes.

USDA Seeks Applications for Grants to Help Agricultural Producers and Rural Small Businesses Develop New Products

The deadline to apply is March 10, 2020.

The U.S. Department of Agriculture (USDA) Rural Development is accepting applications for grants to help farmers, ranchers, and producer-based businesses develop new products and expanding marketing opportunities.

Rural Development is making approximately \$37 million in grants available nationwide under the Value Added Producer Grant (VAPG) Program. The grants can be used to develop new products from raw agricultural products, to develop additional uses for already developed product lines, or to market value-added agricultural products.

Independent producers, agricultural operators, farmer or rancher cooperatives, and majority-controlled producer-based business ventures are eligible to apply. Priority will be given to

veterans, socially-disadvantaged groups, beginning farmers and ranchers, operators of small- and medium-sized family farms and ranches, and farmer and rancher cooperatives.

Electronic applications must be submitted to grants.gov by 10:00 pm EST on March 5, 2020.

Paper applications must be submitted by 4:30 pm EST on March 10, 2020. In Delaware and Maryland, applications should be submitted to your local USDA Rural Development office.

We strongly encourage you to contact a local Business and Cooperative Program Specialist prior to beginning work on your application for more details about the requirements and process. VAPG toolkits and other useful resources can be found on our website.


