# Chesapeake Utilities and Sharp Energy Present: A Builder's Guide to Natural Gas and Propane Service

For builders and developers planning new communities, ensuring the availability of gas amenities is crucial for constructing homes that are both marketable and competitive.

Recent findings indicate that homebuyers increasingly favor homes equipped with natural gas. A poll by the nonprofit Rewiring America revealed that only 31% of respondents preferred electric-only appliances. Funded by donations from our customers. employees and corporate sponsors, more than \$500,000 has been distributed to those

The event includes lunch and

a tour of Chesapeake Utilities' state-of-the-art, hands-on training facility, Safety Town. Completed in November 2020, Safety Town serves as a resource for our employees who build, maintain and operate our natural gas infrastructure, offering hands-on training and fully immersive, on-the-job field experiences. First responders and other community partners also benefit from the simulated conditions they could encounter as they enter homes in the community. The training center features specialized learning environments, including simulations for hit line and gas leaks, service hook-ups, utility

locating,
leak detection and corrosion
monitoring. The facility has
played a vital role in enhancing
the safety of our employees
and our communities, and
equipping our community
partners to respond to emergencies.

This educational session is tailored for developers seeking to offer gas access on builder lots and homebuilders looking to provide the most competitive amenities. Learn about the opportunities available with natural gas and community propane systems, along with best practices for evaluating and implementing them in your projects. # **Spicy Chicken eatery coming to Dover**

# HANGRY JOE'S HOT CHICKEN WINGS

Hangry Joe's Hot Chicken & Wings to open location in Capital Station this Fall/Winter

Buildout on a new Nashville-style chicken restaurant
has begun in Dover's Capital
Station shopping center on
Division Street and DuPont
Hwy. Hangry Joe's Hot Chicken
& Wings will likely be the
first of the chain's stores to
open in Delaware in late fall/
early winter 2024 when construction is expected to be
complete. A location is also
currently planned in Wilming-

Anticipating continued population and economic growth in Dover, the franchisee group noted that the downtown development plans and proximity to the Dover Air Force Base also drew them to the location. Additionally, they believe the restaurant sector is underserved in Dover and they're confident the chain's menu that includes chicken wings, wraps, fingers, nuggets and their signature "Sando" sandwich will be embraced by locals.

The chain has dozens of locations snaking up from Virgina, Washington DC, Baltimore, Philadelphia and through to New York, making expansion into the first state a natural step. The franchisee notes that the Delmarva peninsula could see up to six more locations in the coming years if current expansion plans continue.

Charles Rodriguez of R&R Commercial Realty, who brokered the deal, says with the addition of Hangry Joe's the large Capital Station shopping center is almost completely full.

"It's taken a few years to build it out and fill it up, but Capital Station has grown into one of Dover's top business hubs," he said. "It has a strong mix of business types now and it attracts consistent traffic. It's come a long way from its past life as the old, shuttered Playtex factory."

# And So It Begins - A New Year of Leadership!









Anticipation filled the air as representatives from a plethora of community organizations and agencies filled the room at the Central Dover Aviation Complex, formerly known as Dover's Civil Aviation Terminal. Statewide entities, local groups, politicians, base representatives, and more, were ready to celebrate a milestone that had been a long time in the making!

Expanded use of Dover Air Force Base's (DAFB) facilities for approved civilian/commercial flight operations is now allowed following the signing of a joint use agreement by Secretary Nicole Majeski of the DE Department of Transportation and Colonel William "Chris" McDonald, Commander of the 436th airlift wing. This new agreement will nearly double the number of flight operations allowed and will



expand the lease term to 50 years at the Dover Aviation Complex, a regional airport managed by the Delaware River & Bay Authority (DRBA). The complex will also receive its own three-letter airport designation.

This new agreement promises to have a major impact on economic development as it attracts businesses to our region. The signing of the agreement also showcases the unique ability of Delawareans to come together to work collaboratively for the benefit of our state. This momentous occasion speaks to the well-known adage that claims that we can do far more together than we could ever do on our own. 
