Dear Members of the CDCC,

As your “opportunity hub,” the Central Delaware Chamber of Commerce (CDCC) prides itself on being acknowledged as one of the best chambers in the country. According to the U. S. Chamber of Commerce, the CDCC excels in programming, advocacy in legislation, training emerging leaders, general communications, and goal setting. Our 5-star accreditation places us in the top 2% of chambers in the country and assures our membership that they are receiving the highest quality services available from a local chamber.

Much like in your own businesses, we have experienced a significant increase in costs over the past year. Many of our signature events are costing more, health care for our incredible staff has become more expensive, and even basic supplies that keep us running are increasing in price. To maintain the high quality that you have come to know, trust, and appreciate, we are now in a position of having to increase our membership dues.

Beginning this month, membership dues will increase by 15% across the board. Whether you are at the lowest dues rate or the highest, the increase will be the same percentage. While this may be difficult news to both hear and deliver, we believe that the value of your member benefits still far outweighs the annual cost.

There is an available benefit that you may want to take advantage of – it’s called the “Early Bird Discount.” Here’s how it works: if a member pays their annual dues prior to their due date (even if it’s only the day before), they can pay the same rate that they are paying currently. Here’s an example: Suppose your dues rate for this year was \$325, the new rate is \$375, and your due date is August 1st. If you pay anytime between now and July 30th, you can pay just \$325. That’s a savings of \$50 just by paying prior to the deadline. If, however, you pay on August 1st or after, your rate will be \$375.

We are excited about what this year will bring and about all the ways that we, your Chamber, can assist you as you grow your business. Through our efforts in education, we look forward to helping you stay current and informed. Through our advocacy work, we are happy to work hard with our lawmakers to ensure business-friendly legislation. We are excited to help you tell your story and take advantage of the marketing tools we offer. And we very much anticipate a year of connections as we create moments and events that motivate helpful, quality networking.

Century Engineering and the Camden Bypass Projects



Century Engineering has played an integral role in the design for both Camden Bypass projects over the past several years. Our involvement began in the planning stages and has continued through design, public outreach, and collaboration with the construction team to address issues as they arise during construction.

East Camden Bypass – Now Under Construction!

The East Camden Bypass is currently under construction. This new roadway, located east of US 13, begins at the US 13/Wawa entrance at Willow Grove Road (future connection to the West Camden Bypass) and extends north to SR 10 and Rising Sun Road, where a five-leg roundabout is proposed. From there, the roadway continues north and ties back into US 13 at the Old North Road intersection. Allen Myers was awarded the \$22.3 million contract and began construction in July 2024. In addition to the new roadway, the project includes:

- ponds
- Drainage improvements
- Sewer and water line installations
- Lighting and signal upgrades
- A multi-use trail for pedestrian access
- Bus stops to support public transit

The East Camden Bypass is a true example of a multi-modal transportation project.

Construction Phases and Progress

Currently, they are completing Phase I of construction, which has included the development of stormwater ponds and roadway work on both sides of SR 10, east of US 13. This phase has been completed with minimal impact to existing traffic. Next, Phase II will begin with the temporary closure of Rising Sun Road to allow for roundabout construction. This work is expected to start soon and will last approximately three months. Phase III will follow, involving a closure of SR 10 between US 13 and Rising Sun Road to

complete the roundabout, expected to last about one month. DelDOT anticipates opening the East Camden Bypass in spring 2026, weather permitting.

West Camden Bypass – Coming Soon

The East Camden Bypass is one half of the overall Camden Bypass initiative. The second half, the West Camden Bypass, is a new roadway west of US 13. It will extend from Willow Grove Road, past South Street, Upper King Road/Main Street, and King Boulevard, tying into US 13 at the Wawa traffic signal. Construction is scheduled to begin this summer. Once both projects are completed, the Camden Bypass will provide an alternative route for through traffic, allowing vehicles, especially heavy trucks—to bypass the Historic Town of Camden. This is expected to significantly improve safety and reduce congestion in the town center.

Partnering with Education: A STEM Learning Opportunity

With the East Camden Bypass located just a few hundred feet from Caesar Rodney High School, DelDOT has partnered with the school's STEM teachers to provide students with real-world experience. The project team began by presenting the project in a classroom setting, walking students through the engineering and planning processes. Students then visited the construction site to observe operations firsthand, including a live drone demonstration. Both the students and the project team found the experience highly valuable. With construction activity expected to continue in the area for the next several years, more educational field trips are planned.

The Class of 2025 Ends the Year with Energy!

As Leadership Central Delaware's year of day-long learning experiences came to a close with Energy & Environment Day, the class gathered in Chesapeake Utilities' state-of-the-art classroom for a panel discussion focused on what it means to be in the energy business in Delaware. The group was given a warm welcome by Shane Breakie, Vice President of Chesapeake Utilities, LCD Alum (Class of 2007), and former CDCC Board Chair. Shane gave a brief overview of Chesapeake Utilities and all they do for the Central Delaware community and beyond.

Next, a panel of energy experts was gathered, each with a different perspective, to share with the class about the "business of energy." Panelists included Jen Vandervort (LCD Class of 2018) from Chesapeake Utilities, Heather Contant (LCD Class of 2021) from Delaware Municipal Electric Corporation, Lauren Irby (LCD Class of 2021) from Delaware Electric Cooperative, and Chad Jackson of Affinity Energy Management. The panelists spent time discussing their companies' various roles in energy. They also shared challenges and trends in the industry that will likely affect their customers, both residents and businesses. They ended their time with the group by sharing leadership techniques, tips, and strategies that

they've learned over the years in their various roles.

After much conversation about electricity and natural gas, we turned out attention to an alternative form of energy, we welcomed Dora Cheatham, Vice President, Sales & Commercialization at Aternium (formerly First State Hydrogen) to the podium. She presented the ground-breaking advances within the Hydrogen and the Mid-Atlantic Clean Hydrogen Hub (MACH2). This initiative is revolutionary for Delaware and will usher in a new era of economic development for the state. She gave background of hydrogen as a power source, its consumption, production, and how Delaware ranks among competitors in utilization and production. She made this scientific topic very easy to understand how her work is positively impacting Delaware's energy model.

The class then had the unique opportunity to visit Chesapeake Utilities training facility, "Safety Town." Safety Town's training rooms and shed-like houses (built by students from Polytech) were built on a 2-acre parcel of Chesapeake's Energy Lane campus. The homes give workers a simulated experience of what they may encounter as they enter customer homes on installation and repair calls. Chesapeake's Training Coordinators Anthony Coker, LCD Alum (Class of 2021), and Dave Baldinger explained

the facility to the class and underscoring the importance of safety training.

After a delicious lunch by The Skyline Cafe, the Class of 2025 heard from Delaware Department of Natural Resources and Environmental Control (DNREC) Secretary Greg Patterson. Sec. Patterson spoke at length about the role of DNREC in protecting and preserving the environment and ensuring good stewardship of Delaware's natural resources. He shared various ways that individuals can be engaged with DNREC in educational and recreational experiences. His time with the group ended with a short session of Q & A.

The Class of 2025 left Chesapeake Utilities and traveled across the parking lot to the Delaware Solid Waste Authority's (DSWA) beautiful, new facility. There they learned about the work of DSWA in educating people about appropriate practices for disposing of their trash and recycling. They discussed document shredding, disposal of hazardous waste, collection events, and how the DSWA provides an abundance of opportunities for the community.

Finally, an already eventful Energy & Environment Day got more eventful at the Kent County Wastewater treatment facility in Milford. The class by a man who has done this LCD tour for more than 20 years, the passionately knowledgeable, William Vincent.

He walked the class through their outdoor operation of turning sewage into usable water and fertilizer. This facility has been visited by engineers from all around the world because it is one of the first locations to utilize Severn Trent's Microdynamic UV light system to disinfect the water. The class did a great job of bearing the unpleasant smell and gained valuable insight into the operation that processes more than 14 million gallons per day and 8,000 tons of biosolids a year – fascinating! On a personal note, the class was also informed of the end of an era: Mr. William Vincent is retiring this summer! Thank you, Bill, your service of 40 years to the people of Kent County – and all the best in your retirement.

Energy & Environment Day turned out to be an information-packed day for the class members. They were extremely engaged in the conversations and asked many questions. They seemed very interested in what the energy of the future would enable people to do differently. They found the day helpful and relevant, found a new appreciation for the environment and for the way it provides for us, and are resolved to be much more discerning about what gets "flushed." One might say that the conversation left them pretty "charged up!"



Closing Retreat: A Time to Remember, Reflect, and Continue the Journey!

After an information-filled, relationship-building, experience-packed ten months, it is imperative to spend some time debriefing, applying, synthesizing, and discovering what it all meant and exploring its importance. That is exactly what the Annual LCD Closing Retreat is all about. The Closing Retreat is designed to be part educational and part reflective, all said and done to place a bold exclamation mark at the end of this year's LCD story.

On Friday, June 13th, class members gathered at Harvest Ridge Winery for a full day of presentations and conversations. Our first special guest speaker of the day was Laura Garofoli, owner and operator of Lean on Me Caregiving, LLC. Laura is an LCD alum (Class of 2022) and a member of the CDCC Board of Directors. Laura shared her personal leadership journey with the class, complete with ups and downs, blessings and challenges, difficult moments, life-changing circumstances and all the rest. Through her inspiring experience, the class learned much about determination, persistence, grit, goals, and overcoming circumstances that seem outside one's control.

Javier Santana, owner of High Ground Solutions, and CDCC Board Member, shared some thoughts about leadership around the topic: Live Now and Leave a Trail: The Soul of Leadership. He spent time focusing on the importance of NOW. He remarked about the importance of reflection and really counting every moment as a gift. He encouraged the group, as they move on from here, to live in such a way that it creates a positive, lasting impact. He stressed that

a large outcome of effective leadership is a legacy that informs those who come after us.

The class had the opportunity to hear from representatives of LCD's partner organizations, Wilmington University and Leadership Delaware, Inc. (LDI). Mike Eppehimer, CEO of LDI, and Carrie Hart, current LDI fellow and LCD alum, spoke with the group regarding LDI's potential to be a good "next step" in their leadership journey. They also shared that LDI is happy to grant a significant discount on tuition for graduates of LCD. Kathy Kennedy-Ratajack of Wilmington University shared that Wilmington University recognizes the significant learning accomplished through LCD and is happy to grant each LCD graduate 3 credit hours towards a degree program at the university. Class members were very excited about these opportunities as they begin to plan their next leadership adventure!

The final speaker of the day was Tim Bays, Program Manager at Century Engineering: A Kleinfelder Company, and member of the CDCC Board of Directors. Tim had the unique opportunity to speak with the Class of 2025 at both their Opening Retreat and their Closing Retreat! Tim did a wonderful job of helping the class think about what happens next. He urged them to continue learning and always work towards refining their ability to lead. He reminded them of the human element of leading, the importance of listening, and the benefits of practicing the pause.

As the year grew to a close, the class was surprised to realize how much they had poured into this experience! In review, this year's class was comprised

of 28 individuals representing 19 companies. Throughout their year, they spent more than 140 hours together as they studied 9 industries that serve as our county's largest economic drivers. They heard from 85 speakers, they each wrote about 85 thank you notes, and they performed 85 2-minute speaker introductions. They heard from 2 cabinet secretaries, 1 mayor, about 15 LCD alumni, several educators, several people in law enforcement, a few farmers, 1 horse trainer, 1 horse, and 1 man who really loved his odiferous job at the wastewater treatment facility, and more. They read a book together and they completed two community impact projects.

The Class of 2025 spent some time intentionally remembering and reflecting on the various aspects of their LCD experience including their monthly experiences, their class book: It's Your Ship, their journals, their Community Impact Projects, and more. The conver-

sation was built around the theme, "What Did It All Mean?" While class members enjoyed the many facets of the program and felt like they gained a great deal of knowledge from the various speakers and presenters throughout the year, they all acknowledged that they learned a great deal from each other! Class members offered valuable suggestions for additions to the program in the future. They were eager to share their discoveries and their learnings from the year and showed a great deal of gratitude for having been part of the Chamber's "Diamond Program."

The Closing Retreat came to its conclusion with the fun distribution of class superlatives and a champagne toast to the Class of 2025. Class members, presenters, and volunteers experienced a full day and left with full hearts as they spoke about graduation, next steps, and plans for remaining in touch.

Each year, high school students from across the country gather for a fun-filled week of leadership development while exploring our nation's capital. DEC selects three students who are currently in their junior or senior year of high school and live in homes served by DEC, to serve as delegates and to represent the Cooperative on the national stage. This year's delegates were Caesar Rodney students Eugene Ma, James Poplos, and Erica Weller.

DEC's Youth Tour delegates traveled with Virginia and Maryland delegates to join over 1,000 students from across the nation for Youth Tour. During their visit to the nation's capital, they toured the memorials for Franklin Delano Roosevelt, Thomas Jefferson, and Martin Luther King, Jr., and visited Arlington National Cemetery, the National Air and Space Museum, and National Museum of African American History & Culture. They cheered their favorite team at a Major League Baseball Game between the Washington Nationals and the Colorado Rockies and enjoyed a dinner cruise on the Potomac River.

The Youth Tour experience for the Delaware was also packed with educational activities and exciting events, including networking and trading collectible pins with student leaders from across the U.S., and meetings with U.S. Senator Chris

Coons and U.S. Congresswoman Sarah McBride's staff on Capitol Visit Day. DEC paid for all the transportation, meals, hotel accommodations, and admission fees during the trip. They also provided chaperones to ensure that students were well taken care of throughout the entire experience.

James Poplos, DEC Youth Tour participant and Delaware's YLC (Youth Leadership Council) Representative, shared his enthusiasm for the program, "Youth Tour 2025 was an incredible experience! Big thanks to Delaware Electric Coop for sending Erica, Eugene, and me! We met so many great people, did some awesome things, and collected a ton of pins!"

It's evident that Youth Tour is more than just a trip; it's a chance to make lifelong friendships and join a vibrant community of over 50,000 alumni. This program has provided high school students with valuable experiences that will last a lifetime whether they're interested in leadership,

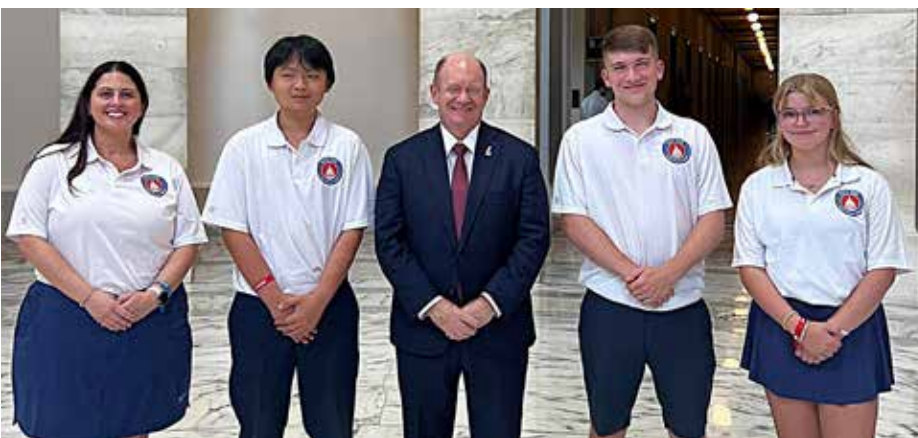

Baines Johnson said in his address to the association, "If one thing comes out of this meeting, it will be sending youngsters to the national capital where they can actually see what the flag stands for and represents." Thus, NRECA's Electric Cooperative Youth Tour was born!

Remembering the Past, Planning for the Future



AIR MOBILITY COMMAND MUSEUM

The staff at the Air Mobility Command (AMC) Museum is always looking for new and innovative ways to tell the stories of the people who served in our nation's US Army Air Corps, the US Army Air Forces, and the US Air Force. A project designed to do that is in the works right now.

Deputy Director Eric Czerwinski is leading the refocus of 4 displays to tell stories from World War II, the Korean War, Vietnam War and more recent history from the 1980s to the present day. Eric explained that the Museum staff are thrilled that these displays are each being set up as fully professional museum exhibits. Although they have a small staff working on this project, everything is being done in-house. Because of a grant from the Air Education and Training Command, they can upgrade the lighting, technology, graphics, and other elements to museum standards. Even so, the local team is still the driving force behind this effort: designing the visual elements, outfitting the mannequins, building the displays and more.

Each display will be a separate room that features a building façade at the entrance from the themed era. The inside will be filled with a large variety of never-displayed artifacts, storyboard backdrops, costumed mannequins and on-screen streaming videos of associated period news broadcasts to enhance the visual storytelling.

The World War II display room will include a focus on Women's services during the War. There will be three women featured with a photo and text backdrop detailing each of their stories and mannequins outfitted in their actual uniforms. Plus, other pieces of their

personal artifacts will be included in the display. These women served as cooks, nurses and pilots during the War, each accomplishing amazing and brave feats during their service.

The Cold War display room will include information on the late 1940s Berlin Airlift which supplied food, fuel, and medicine to Western Berlin residents, in addition to the Western Allies. It will even include information about Colonel Gail Seymour Halvorsen who was nicknamed the "Berlin Candy Bomber" and became famous during the Berlin Airlift for dropping candy to German children. The Airlift was a major victory for the Western Allies during the Cold War, demonstrating their resolve and commitment to defending West Berlin.

The Cold War display room will also focus on the Chosin Reservoir campaign fought during the Korean War. This key battle occurred in late 1950, during a particularly brutal North Korean winter. The US Air Force played a crucial role by supporting United Nations (UN) forces through airlift operations of vital resupply of food, ammunition, and other necessities, as well as medical evacuation of wounded soldiers and helping to protect retreating forces and inflicting casualties on the enemy. The visual design of this room will convey the extreme cold temperatures endured by the UN forces during this campaign.

The Present Day display room will focus on operations in the Middle East including Desert Shield,

Desert Storm and Iraq Freedom. In addition, there will be displays on the humanitarian operations that have and continue to be carried out by the US Air Force. These include responding to worldwide natural disasters such as hurricanes, earthquakes, and floods by providing airdrops of food and medical supplies, conducting rescue operations, and assisting with the delivery of humanitarian aid.

The Vietnam War display room will remain unchanged. The current display was produced just over a decade ago, and includes a unique display of personal artifacts, visual backdrops focusing on the Airlift and Air Refueling during the Vietnam War, Strategic Airlifts, and Prisoners of War.

Deputy Director Czerwinski was eager to show the Chamber Connections editor the AMC Museum's collections storage area filled with all sorts of artifacts including uniforms, shoes, accessories, glasses, patches, equipment, and even more historical treasure than can be listed in this article. This storage area provides a secure, atmospherically controlled environment to maintain everything the Museum needs for their displays. The challenge is having the space to display everything that they want to share.

Eric shared his excitement about the AMC Museum expansion plans for a second, modern hangar with an education/conference center to house several new aircraft, eight classrooms, an IMAX theater,

cafeteria, banquet center, and much more...including expanded indoor exhibit space. The AMC Museum Foundation will need support from our local community to make this happen. While you are visiting the AMC Museum to view the progress on their 4 display rooms, be sure to visit the display for Private First-Class Mildred E. Higgins Rice. You'll gain insight into the loss of her C-47 off the African coast and see the special donation that her family made to the AMC Museum.

You can learn more about the AMC Museum at www.amcmuseum.org. They are open Wednesday through Sunday, 9 a.m. to 4 p.m. at 1301 Heritage Rd., Dover AFB, DE. Admission and parking are free. Open Cockpit Day is every third Saturday of the month, April through October. This day provides the public full access to many of the museum's aircraft and tour guides are available.

Check Out the New Duck Creek Regional Library

It took about a decade and a half, give or take a year, for the dreams of the Friends of Duck Creek Regional Library community group to become a reality. The new library in Smyrna is quite the dream, expanding from 2,500 square feet to their current size of 22,000 square feet. To put it in perspective, 2,500 square feet is less than half the size of a basketball court, and 22,000 square feet is less than half the size of a football field.

With that said, the new library is much, much more than additional square feet. It's all about what they have done with this space. Library Director, Pat Young, was happy to take the Central Delaware Chamber of Commerce (CDCC) on a recent tour of the new Duck Creek Regional Library and show us firsthand what the new Library is all about.

The additional square feet has allowed them to add meeting and program spaces...enough to offer 7 different programs all happening simultaneously. As Pat pointed out, "These spaces aren't reading rooms." She went on to explain they include all the latest technology with video screens, interactive whiteboards, plenty of electrical outlets, and versatile seating setups – from classroom style to conference room to workspaces with adjustable table heights to round banquet tables accommodating 8 people at each.

The rooms vary in size to suit any sort of program or meeting with some including counter space, a sink and the largest includes a full catering kitchen.

These rooms are available for public use, and the library currently has an extensive list of programs planned in these spaces with many new and additional ones to come, think concerts, lectures, art shows, etc. The rooms must be reserved, so don't wait if you want to have a meeting or presentation in this new space.

In addition to the new meeting spaces, the Library offers two study rooms with all the necessary technology available for today's students or entrepreneurs. Plus, there are computers available in small cubicles for public use, wireless printing, and you can even borrow a charger to give your techno gadgets a power boost while you're working onsite.

You can even check out your books at a self-checkout kiosk. All you need is a library card. Even so, Pat pointed out, "The Library staff is always available to help you with anything you need. We want to make sure that we maintain our personal service approach."

Speaking of books, are you wondering what new reading opportunities are being offered? A family reading area has been set up to better accommodate all age groups in one space. The teen room offers books for ages 12 – 18, along with board games and soon-to-be added video games, making it the perfect hangout for young adults.

There is a large central reading area with high ceilings, plenty of natural light, comfortable seating and a display of sculptures by local

artist Richard Bailey. It's the perfect calming spot to take a break and start a new book. Adjacent to this space is an outdoor reading area – another great spot to relax and enjoy a journey into another world with a new book. There are plans to add plants and shade areas to this outdoor space to turn it into a true reading garden.

Is there a children's area? Yes, and it's an inspiring space for the youngest of readers. The nature-themed décor includes leaf-shaped beanbag seating, mountainscapes on the walls, and pint-sized chairs with racoon tails. There are crayons, coloring pages, computers with children's games queued up, and educational toys scattered about, in addition to multiple cases full of children's books from all time favorites to the ones that are quickly gaining popularity. This will become the go-to spot for all parents on both sunny and rainy days. There's nothing like the cool, calm space of a library on a hot summer day!

Pat pointed out that they have added adult non-fiction and biographies audio books to their collection, also children's music CDs, and a literacy collection to develop and foster reading skills. They will add additional materials to their collections as they find out what the community needs and wants. "We have to pay attention to the community," Pat points out.

There are many things that you can get with

your library card that you probably don't even know about including: checking out a blood pressure cuff or a telescope. You can also obtain museum passes for Longwood Gardens for free, read the digital version of a huge number of popular magazines and plenty more.

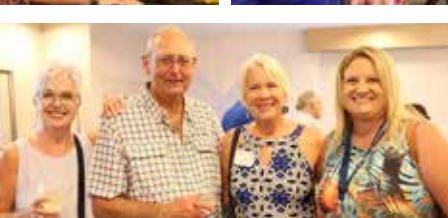
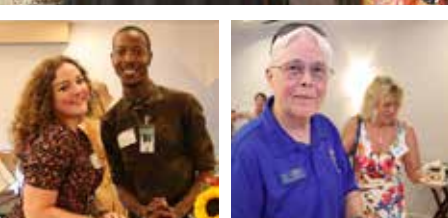
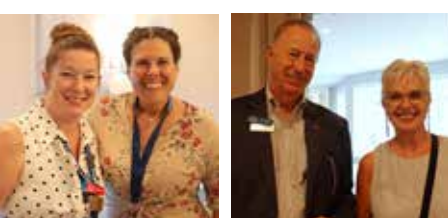
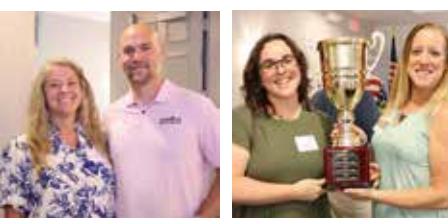

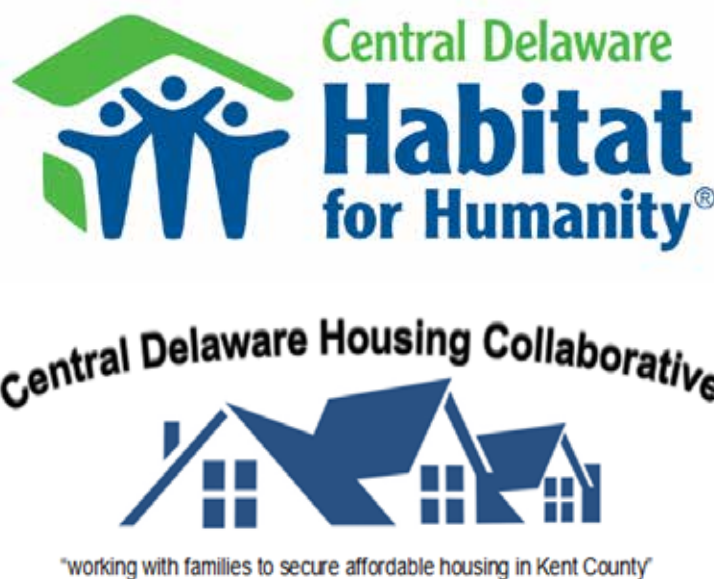
ment store and donation center. They sell new and gently used furniture, appliances, home accessories, and more to the public for a fraction of retail
